

A BILL FOR AN ACT

To further amend Public Law No. 10-120, as amended, by amending section 1 to change the use of funds appropriated for Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 10-120, as amended by
2 Public Laws Nos. 10-122, 10-144, 11-8, 11-20, 11-32 and 12-6, is hereby
3 further amended to read as follows:

4 "Section 1. The sum of \$5,000,000, or so much thereof as may
5 be necessary, is hereby appropriated from the General Fund of
6 the Federated States of Micronesia for the fiscal year ending
7 September 30, 1999, for the purpose of funding infrastructure
8 and other projects and programs in the State of Chuuk. The
9 funds appropriated under this section shall be apportioned as
10 follows:

11 (1) Regional transportation projects (which shall be deemed
12 to come from capital account funds available under section
13 211 of the Compact of Free Association)
