

A BILL FOR AN ACT

To further amend Public Law No. 11-59, as amended, by amending section 1 thereof, to reduce and increase certain funds appropriated for projects and programs in Kosrae State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 11-59, as amended by
2 Public Laws Nos. 11-69, 11-79 and 12-33, is hereby further amended
3 to read as follows:

4 "Section 1. The sum of \$350,000, or so much thereof as
5 may be necessary, is hereby appropriated from the
6 General Fund of the Federated States of Micronesia for
7 the fiscal year ending September 30, 2001, to provide
8 funds for infrastructure and other projects and programs
9 in the State of Kosrae. The funds appropriated under
10 this section shall be apportioned as follows:

- 11 (1) Youth conferences..... [~~40,000~~]\$ 36,611
- 12 (2) Shipping subsidy [~~15,000~~]18,389
- 13 (3) Kosrae Visitors Bureau, PROVIDED that
14 no more than \$10,000 of this appropriation
15 may be used for the purchase of a vehicle .. 17,000
- 16 (4) Medical School Scholarships for
17 Kosraean students studying in Fiji 10,000
- 18 (5) Senior citizens social activities..... 5,000
