

A BILL FOR AN ACT

To further amend Public Law No. 6-49, as amended, by amending section 10 for the purpose of changing the allottee of funds previously appropriated for public projects in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 10 of Public Law No. 6-49, as amended by
2 Public Laws Nos. 6-96, 6-112, 7-3, 7-26, 7-58, 8-124, 9-032 and
3 13-25, is hereby further amended to read as follows:

4 "Section 10. Allotment and management of funds and
5 lapse date. All funds appropriated by this act
6 shall be allotted, managed, administered, and
7 accounted for in accordance with applicable law,
8 including, but not limited to, the Financial
9 Management Act of 1979. The allottee of the funds
10 appropriated by section 4 of this act shall be the
11 Executive Director of the Chuuk State Commission on
12 Improvement Projects. The allottee of the funds
13 appropriated by section 3 of this act, for Chuuk
14 State Election District #3, shall be the Chuuk State
15 Office of Planning and Statistics. The allottee of
16 the funds appropriated by subsection (2) of section
17 1 of this act shall be the Chuuk Organization of
18 Community Action (COCA); the allottee of the funds
19 appropriated by subsection (4) of section 1 shall be

1 the Lower Mortlocks Development Authority; and the
2 allottee of the funds appropriated by subsections
3 (1), (3), (5), (6), (7), (8), (9), (10), and (11) of
4 section 1 and by subsections (1), (2), (3), (4), and
5 (5) of section 2 shall be the Governor of Chuuk
6 State; the allottee of subsection (6) of section 2
7 shall be the Northern Namoneas Development
8 Authority. The allottee of the funds appropriated
9 under subsection (12) of section 1 of this act shall
10 be the Peace Corps Representative, Chuuk State. The
11 allottees of the funds appropriated by sections [3],
12 5, 6, 7, 8, and 9 of this act shall be the local
13 development authorities of the areas for which the
14 projects are designated. The allottees shall be
15 responsible for ensuring that these funds, or so
16 much thereof as may be necessary, are used solely
17 for the purposes specified in this act, and that no
18 obligations are incurred in excess of the sum
19 appropriated. The authority of the allottees to
20 obligate funds appropriated by this act shall not
21 lapse until expended."
