

A BILL FOR AN ACT

To further amend Public Law No. 9-100, as amended, by amending section 5 to change the allottee for certain funds previously appropriated to Election District No. 1 in Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 5 of Public Law No. 9-100, as
2 amended by Public Laws Nos. 10-20, 10-44, 10-73, 10-116, 10-
3 117, 12-8 and 12-62 is hereby further amended to read as
4 follows:

5 "Section 5. Allotment and management of funds and
6 lapse date.

7 (1) All funds appropriated by this act shall be
8 allotted, managed, administered, and accounted for
9 in accordance with applicable law, including, but
10 not limited to, the Financial Management Act of
11 1979. The allottee of the funds appropriated under
12 subsection (1) of section 1 of this act shall be the
13 Governor of the State of Chuuk. The allottee of the
14 funds appropriated under subsection (2) (a), (2) (b),
15 (2) (c) and (2) (d) of section 1 of this act shall be
16 the Toleisom Authority. The allottees of the funds
17 appropriated under subsection (2) (e) and (2) (f),
18 except for funds appropriated under subsection
19 (2) (e) (iv) and (2) (f) (iv), of section 1 of this act

1 shall be the mayors of the respective
2 municipalities. The allottee of the funds
3 appropriated under subsection (2)(e)(iv),
4 (2)(f)(iv), (2)(g), (2)(h) and (2)(i) of section 1
5 of this act shall be the mayor of Polle
6 Municipality. The allottee of the funds
7 appropriated under subsections (3) and (5) of
8 section 1 of this act shall be the Chuuk State
9 Commission on Improvement Projects. The allottee of
10 the funds appropriated under subsections (4) and (8)
11 of section 1 of this act shall be the Northern
12 Namoneas Development Authority. [~~The allottee of~~
13 ~~the funds appropriated under subsection (5) of~~
14 ~~section 1 of this act shall be the Mortlock~~
15 ~~Development Authority.] The allottee of the funds
16 appropriated under subsection (6) of section 1 of
17 this act shall be the Northwest Islands Project
18 Coordinator. The allottee of the funds appropriated
19 under subsection (7) of section 1 of this act shall
20 be the Speaker of the Congress of the Federated
21 States of Micronesia or the Speaker's designee. The
22 allottee of the funds appropriated under subsection
23 (2) of section 2 of this act shall be the Chairman
24 of the Kosrae Utilities Authority, and the allottee
25 of the funds appropriated under subsection (9) of~~

1 section 2 of this act shall be the Governor of the
2 State of Kosrae. The allottee of the funds
3 appropriated under subsection (1)(a)(i) of section 3
4 of this act shall be the Mayor of Kolonia Town. The
5 allottee of the funds appropriated under subsections
6 (1)(a)(ii)a), (1)(a)(ii)b), and (1)(a)(ii)c) of
7 section 3 of this act shall be the Pohnpei
8 Transportation Authority. The allottee of the funds
9 appropriated under subsection (1)(a)(ii)d) of
10 section 3 of this act shall be the Chief Magistrate
11 of Sokehs Municipality. The allottee of the funds
12 appropriated under subsection (1)(b) of section 3 of
13 this act shall be the Vice President of the
14 Federated States of Micronesia or the Vice
15 President's designee. The allottee of the funds
16 appropriated under subsection (2)(a) and (2)(b) of
17 section 3 of this act shall be the Pohnpei Visitor's
18 Bureau. The allottee of the funds appropriated
19 under subsections (1) and (3) of section 4 of this
20 act shall be the Governor of the State of Yap. The
21 allottee of all other funds appropriated by this act
22 shall be the President of the Federated States of
23 Micronesia or the President's designee. The
24 allottees shall be responsible for ensuring that
25 these funds, or so much thereof as may be necessary,

1 are used solely for the purpose specified in this
2 act, and that no obligations are incurred in excess
3 of the sum appropriated. The allottees of the funds
4 appropriated under subsection (1)(a) and (1)(b) of
5 section 3 of this act shall not obligate any funds
6 appropriated therein without first consulting with
7 the member of the Pohnpei Delegation to Congress
8 representing the Election District to which the
9 funds are apportioned. The allottees of funds
10 appropriated under subsection (1)(a) of section 3 of
11 this act shall not obligate or expend any funds
12 apportioned under said subsection for travel.

13 (2) The authority of the allottees to obligate funds
14 appropriated by this act shall not lapse."

15 Section 2. This act shall become law upon approval by the
16 President of the Federated States of Micronesia or upon its
17 becoming law without such approval.
