

A BILL FOR AN ACT

To further amend Public Law No. 10-143, as amended, by amending sections 1 and 5 thereof to change the use and allottee of certain funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 10-143, as amended by
2 Public Law No. 11-2 is hereby further amended to read as follows:

3 "Section 1. The sum of \$935,162, or so much thereof as
4 may be necessary, is hereby appropriated from the
5 General Fund of the Federated States of Micronesia for
6 the fiscal year ending September 30, 1999, for the
7 purpose of meeting the needs of primary and secondary
8 public schools and State hospitals and State-
9 administered public health programs and funding social
10 and economic projects or grants in the State of Chuuk.
11 The funds appropriated herein shall be apportioned as
12 follows:

13	(1) Election District No. 1	\$ 150,000
14	(2) Election District No. 2	150,000
15	(3) Election District No. 3	150,000
16	(4) Election District No. 4	
17	(a) Faichuk Community Health Center .	66,000
18	(b) Other projects	125,000

14 Section 2. Section 5 of Public Law No. 10-143, as amended by
 15 Public Laws No. 12-22, 12-31 and 12-41, is hereby further amended
 16 to read follows:

17 "Section 5. Allotment and management of funds and lapse
 18 date.

19 (1) All funds appropriated by this act shall be
 20 allotted, managed, administered, and accounted for in
 21 accordance with applicable law, including, but not
 22 limited to, the Financial Management Act of 1979. The
 23 allottee of the funds appropriated under section 1(1) of
 24 this act shall be the Executive Director of the Mortlock
 25 Development Commission, or his designee. The allottee

1 of
2 the funds appropriated under section 1(2) of this act
3 shall be the Executive Director of the Northern Namoneas
4 Development Authority or his designee. The allottee of
5 the funds appropriated under section 1(3) of this act
6 shall be the Executive Director of the Chuuk State
7 Commission on Improvement Projects. The allottee of the
8 funds appropriated under section 1(4) of this act shall
9 be the Mayor of Polle. The allottee of the funds
10 appropriated under section 1(5) of this act shall be the
11 Northwest Islands Project Coordinator or his designee.
12 The allottee of the funds appropriated under section
13 1(6) of this act shall be [~~the Secretary of the~~
14 ~~Department of Health, Education and Social Affairs of~~
15 ~~the Federated States of Micronesia, or his designee]~~ the
16 Chuuk State Commission on Improvement Projects. The
17 allottee of the funds appropriated under section 2(1)(b)
18 of this act shall be the Mayor of Kolonia. The allottee
19 of the funds appropriated under section 3 of this act
20 shall be the Governor of the State of Yap or the
21 Governor's designee. The allottee of the funds
22 appropriated under section 4 of this act shall be the
23 Governor of the State of Kosrae or the Governor's
24 designee. The allottee of all other funds appropriated
25 by this act shall be the President of the Federated

1 States of Micronesia or the President's designee. The
2 allottees shall be responsible for ensuring that these
3 funds, or so much thereof as may be necessary, are used
4 solely for the purpose specified in this act, and that
5 no obligations are incurred in excess of the sum
6 appropriated.

7 (2) The authority of the allottees to obligate funds
8 appropriated by this act shall not lapse."

9 Section 3. This act shall become law upon approval by the
10 President of the Federated States of Micronesia or upon its
11 becoming law without such approval.
