

A BILL FOR AN ACT

To further amend Public Law No. 6-49, as amended, by amending section 10 for the purpose of changing the allottee of funds previously appropriated for public projects in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1           Section 1. Section 10 of Public Law No. 6-49, as amended by  
2 Public Laws Nos. 6-96, 6-112, 7-3, 7-26, 7-58, 8-124, 9-032 and  
3 13-25, is hereby further amended to read as follows:

4           "Section 10. Allotment and management of funds and  
5 lapse date. All funds appropriated by this act  
6 shall be allotted, managed, administered, and  
7 accounted for in accordance with applicable law,  
8 including, but not limited to, the Financial  
9 Management Act of 1979. The allottee of the funds  
10 appropriated by section 4 of this act shall be the  
11 [~~Executive Director of the Chuuk State Commission on~~  
12 ~~Improvement Projects~~] Mayor of Polle Municipality.  
13 The allottee of the funds appropriated by subsection  
14 (2) of section 1 of this act shall be the Chuuk  
15 Organization of Community Action (COCA); the  
16 allottee of the funds appropriated by subsection (4)  
17 of section 1 shall be the Lower Mortlocks  
18 Development Authority; and the allottee of the funds  
19 appropriated by subsections (1), (3), (5), (6), (7),

1 (8), (9), (10), and (11) of section 1 and by  
2 subsections (1), (2), (3), (4), and (5) of section 2  
3 shall be the Governor of Chuuk State; the allottee  
4 of subsection (6) of section 2 shall be the Northern  
5 Namoneas Development Authority. The allottee of the  
6 funds appropriated under subsection (12) of section  
7 1 of this act shall be the Peace Corps  
8 Representative, Chuuk State. The allottees of the  
9 funds appropriated by sections 3, 5, 6, 7, 8, and 9  
10 of this act shall be the local development  
11 authorities of the areas for which the projects are  
12 designated. The allottees shall be responsible for  
13 ensuring that these funds, or so much thereof as may  
14 be necessary, are used solely for the purposes  
15 specified in this act, and that no obligations are  
16 incurred in excess of the sum appropriated. The  
17 authority of the allottees to obligate funds  
18 appropriated by this act shall not lapse until  
19 expended."
