

A BILL FOR AN ACT

To further amend Public Law No. 7-24, as amended, by amending section 3 thereof to change the use of certain funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 7-24, as amended by
2 Public Laws Nos. 7-63, 7-74, 7-112, 8-119, and 11-13, is hereby
3 further amended to read as follows:

4 "Section 3. Nett, U, Mwoakilloa and Pingelap public
5 projects and programs. The sum of \$725,000, or so much
6 thereof as may be necessary, is hereby appropriated from
7 the General Fund of the Federated States of Micronesia
8 for the fiscal year ending September 30, 1992, for the
9 purpose of funding public projects and programs in Nett,
10 U, Mwoakilloa and Pingelap, Pohnpei State. The sum
11 appropriated under this section shall be apportioned as
12 follows:

25 Section 2. This act shall become law upon approval by the
