

A BILL FOR AN ACT

To further amend Public Law No. 9-27, as amended, by amending sections 2 and 5 thereof, to change the use and allottee of certain funds previously appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA

1 Section 1. Section 2 of Public Law No. 9-27 is hereby  
2 amended to read as follows:

3 "Section 2. The sum of \$200,000, or so much thereof as  
4 may be necessary, is hereby appropriated from the  
5 General Fund of the Federated States of Micronesia for  
6 the fiscal year ending September 30, 1995, for projects  
7 in [~~pharmaceutical supplies, lab and dental equipment,~~  
8 ~~and referral programs in~~] the State of Pohnpei as  
9 follows:

10	<u>(1) Completed Projects .....</u>	<u>\$ 50,000</u>
11	<u>(2) ED #2 Road Paving .....</u>	<u>80,000</u>
12	<u>(3) Madolenihmw/Kitti Agriculture Fair ...</u>	<u>20,000</u>
13	<u>(4) Tuition Assistance .....</u>	<u>25,000</u>
14	<u>(5) Project Management ED #2 .....</u>	<u>25,000"</u>

15 Section 2. Section 5 of Public Law No. 9-027, as amended by  
16 Public Laws Nos. 10-65, 12-28, 12-42 and 13-03, is hereby further  
17 amended to read as follows:

18 "Section 5. Allotment and management of funds and lapse  
19 date.

1           (1) All funds appropriated by this act shall be  
2           allotted, managed, administered, and accounted for in  
3           accordance with applicable law, including, but not  
4           limited to, the Financial Management Act of 1979. The  
5           allottee of the funds appropriated under subsection (1)  
6           of section 1 of this act shall be the Director of Health  
7           Services, Chuuk State. The allottee of the funds  
8           appropriated under subsection (2) of section 1 of this  
9           act shall be the Mayor of Polle Municipality. The  
10          allottee of the funds appropriated under subsections (3)  
11          and (5) of section 1 of this act shall be the Chuuk  
12          State Commission on Improvement Projects. The allottee  
13          of the funds appropriated under subsection (4) of  
14          section 1 of this act shall be the Northern Namoneas  
15          Development  
16          Authority. The allottee of the funds appropriated under  
17          subsection (6) of section 1 of this act shall be the  
18          Pattiw Development Authority. The allottee of the funds  
19          appropriated under section 2 of this act shall be the  
20          ~~[Governor of Pohnpei State]~~ President of the Federated  
21          States of Micronesia. The allottee of the funds  
22          appropriated under section 3 of this act shall be the  
23          Governor of Yap State. The allottee of the funds  
24          appropriated under section 4 of this act shall be the  
25          Governor of Kosrae State. The allottees shall be

1 responsible for ensuring that these funds, or so much  
2 thereof as may be necessary, are used solely for the  
3 purpose specified in this act, and that no obligations  
4 are incurred in excess of the sum appropriated.

5 (2) All funds appropriated herein shall not lapse  
6 until fully expended."

7 Section 3. This act shall become law upon approval by the  
8 President of the Federated States of Micronesia or upon its  
9 becoming law without such approval.
