

A BILL FOR AN ACT

To further amend Public Law No. 9-52, as amended, to change the uses of certain funds appropriated for the purpose of funding public projects in Yap, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 9-052, as amended by
2 Public Laws Nos. 9-086 and 9-108, is hereby further amended to
3 read as follows:

4 "Section 4. The sum of \$2,500,000, or so much thereof
5 as may be necessary, is hereby appropriated from the
6 General Fund of the Federated States of Micronesia for
7 the fiscal year ending September 30, 1996, for the
8 purpose of funding infrastructure needs,
9 transportation systems, and other economic and social
10 projects, public projects and for other purposes in
11 Yap State. The funds appropriated under this section
12 shall be apportioned as follows:

14 Section 2. Section 6 of Public Law 9-052, as amended by
 15 Public Laws Nos. 12-30, 12-40, 12-70, 13-4, and 13-29, is hereby
 16 further amended to read as follows:

17 "Section 6. Allotment and management of funds and lapse
 18 date.

19 (1) All funds appropriated by this act shall be
 20 allotted, managed, administered and accounted for in
 21 accordance with applicable law, including, but not
 22 limited to, the Financial Management Act of 1979. The
 23 allottee of the funds appropriated under subsection (1)
 24 of section 1 of this act shall be the Chuuk State
 25 Commission on Improvement Projects. The allottee of the

1 funds appropriated under subsection (2) of section 1 of
2 this act shall be the Executive Director of the Chuuk
3 Housing Authority. The allottee of the funds
4 appropriated under subsections (3), (4) and (5) of
5 section 1 of this act shall be the Executive Director of
6 the Chuuk State Commission on Improvement Projects. The
7 allottee of the funds appropriated under subsection (6)
8 of section 1 of this act shall be the Northern Namoneas
9 Development Authority. The allottee of the funds
10 appropriated under subsection (7) of section 1 of this
11 act shall be the Chuuk State Commission on Improvement
12 Projects. The allottee of the funds appropriated under
13 subsections (1) (b) (i) and (1) (b) (iii) of section 2 of
14 this act shall be the National Planner of the Federated
15 States of Micronesia. The allottee of the funds
16 appropriated under subsections (1) (b) (ii) and (1) (b) (v)
17 of section 2 of this act shall be the Chief Magistrate
18 of Sokehs. The allottee of the funds appropriated under
19 subsections (1) (b) (iv) of section 2 of this act shall be
20 the National Planner of the Federated States of
21 Micronesia. The allottee of the funds appropriated
22 under subsection (1) (c) of section 2 of this act shall
23 be the Mayor of Kolonia Town. The allottee of the funds
24 appropriated under subsection (1) (d) of section 2 of
25 this act shall be President of the Federated States of

1 Micronesia or his designee. The allottee of the funds
2 appropriated under subsection (1)(e) of section 2 of
3 this act shall be the Chief Magistrate of Nukuoro. The
4 allottee of the funds appropriated under subsection
5 (1)(f) of section 2 of this act shall be the Pohnpei
6 Port Authority. The allottee of the funds appropriated
7 under subsections (1)(a) and (3) of section 2 and
8 subsections (2) and (3) of section 3 of this act shall
9 be the President of the Federated States of Micronesia
10 or his designee, except that the allottee of the funds
11 appropriated under subsections (3)(a), (3)(b), (3)(c)
12 and (3)(d) of section 2 of this act shall be the Pohnpei
13 Transportation Authority. The allottee of the funds
14 appropriated under subsections (1) and (4) of section 3
15 of this act shall be the Governor of the State of Kosrae
16 or his designee. The allottee of the funds appropriated
17 under subsections (5)(a), (7) and (8) of section 3 of
18 this act shall be the Mayor of Lelu Municipality. The
19 allottee of the funds appropriated under subsection
20 (5)(b) of section 3 of this act shall be the Mayor of
21 Tafunsak Municipality. The allottee of the funds
22 appropriated under subsection (5)(c) of section 3 of
23 this act shall be the Mayor of Utwe Municipality. The
24 allottee of the funds appropriated under subsection
25 (5)(d) of section 3 of this act shall be the Mayor of

1 Malem Municipality. The allottee of the funds
2 appropriated under subsection (6) of section 3 of this
3 act shall be the Speaker of the Congress of the
4 Federated States of Micronesia or his designee. The
5 allottee of the funds appropriated under subsection (6)
6 of section 4 of this act shall be the Mayor of Rull
7 Municipality. Except for the funds appropriated under
8 subsection (15), for which the allottee shall be the
9 President, [F]the allottee of the funds appropriated
10 under the other subsections of section 4 of this act
11 shall be the Governor of the State of Yap or his
12 designee. The allottees of funds apportioned under
13 subsection (1) of section 2 of this act shall not
14 obligate or expend any of said funds for travel. The
15 allottees shall be responsible for ensuring that these
16 funds, or so much thereof as may be necessary, are used
17 solely for the purpose specified in this act, and that
18 no obligations are incurred in excess of the sum
19 appropriated.

20 (2) The authority of the allottees to obligate funds
21 appropriated by this act shall not lapse."

22 Section 3. This act shall become law upon approval by the
23 President of the Federated States of Micronesia or upon its
24 becoming law without such approval.
