

A BILL FOR AN ACT

To amend Public Law No. 14-21, the FY 2006 budget, as amended, in order to transfer \$60,000 from the Legislature's staff offices contractual services budget to its personnel budget, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 14-21, as amended by
2 Public Laws Nos. 14-50 and 14-70, is hereby further amended to
3 read as follows:

4 "Section 3. Operating expenses of the Legislative
5 Branch.

6 The sum of \$3,203,226 or so much thereof as may be
7 necessary, is hereby appropriated from the General Fund
8 of the Federated States of Micronesia for the fiscal
9 year ending September 30, 2006, for the operations of
10 the Legislative Branch of the National Government during
11 the fiscal year 2006. The sum appropriated by this
12 section shall be apportioned as follows:

13 (1) Speaker and Members.

14 \$1,542,771 or so much thereof as may
15 be necessary, for the operations of the Office
16 of the Speaker and Members of the Congress of
17 the Federated States of Micronesia during the
18 fiscal year 2006. The sum appropriated herein
19 shall be apportioned as follows:

20 Personnel\$ 415,290

1	Travel	\$ 479,881
2	Contractual Services PROVIDED THAT, the full	
3	amount appropriated for each member's	
4	representation fund shall be made available	
5	for use by that member, pending availability	
6	of funds, upon this act becoming law	597,600
7	OCE	50,000
8	Fixed Assets	-0-

(2) Staff Offices.

10 \$1,170,455, or so much thereof as may be
 11 necessary, for the operations of the Congress
 12 staff offices during the fiscal year 2006.

13 The sum appropriated herein shall be
 14 apportioned as follows:

15	Personnel	704,024 <u>764,024</u>
16	Travel	119,371
17	Contractual Services	178,500 <u>118,500</u>
18	OCE	137,340
19	Fixed Assets	31,220

(3) Congress Delegation Offices.

21 \$490,000, or so much thereof as may be
 22 necessary, for the operations of the Congress
 23 delegation offices during the fiscal year
 24 2006. The sum appropriated herein shall be
 25 apportioned as follows:

1	(a) Kosrae Delegation Office	\$ 70,000
2	(b) Pohnpei Delegation Office	140,000
3	(c) Chuuk Delegation Office	210,000
4	(d) Yap Delegation Office	70,000"

5 Section 2. This act shall become law upon approval by the
6 President of the Federated States of Micronesia or upon its
7 becoming law without such approval.
