A BILL FOR AN ACT

To amend Public Law No. 14-84, by amending the title and sections 1, 2, 3, 4, 5, 6, 7, 8 and 9 thereof, to change the uses and allottees of certain funds previously appropriated therein and to make technical changes, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1           Section 1. The title of Public Law No. 14-84 is hereby  
2 amended to read as follows:

3                    "To reappropriate the sum of \$~~[1,325,623]~~ 1,190,020 or  
4 so much thereof as is necessary, from lapsed fund as of June 30,  
5 2006 in the General Fund of the Federated States of Micronesia for  
6 the State of Kosrae, Pohnpei, Yap and Chuuk, for the purpose of  
7 funding public projects and social programs, and for other  
8 purposes."

4           Section 10. Section 9 of Public Law No. 14-84 is hereby  
5 amended to read as follows:

6                   "Section ~~[9]~~ 6. All funds appropriated by this act  
7 shall be allotted, managed, administered, and accounted for in  
8 accordance with applicable law, including, but not limited to,  
9 the Financial Management Act of 1979. The allottee of the funds  
10 appropriated in Sections 1, 4, 5 and 6 of this Act shall be the  
11 President of the Federated States of Micronesia or the  
12 President's designee. The allottee of the funds appropriated in  
13 Sections 2 ~~[7]~~ and 3 ~~[7]~~ ~~[and 4]~~ of this Act shall be the Chuuk  
14 State Commission on Improvement Project. The allottee shall be  
15 responsible for ensuring that these funds, or so much thereof as  
16 may be necessary, are used solely for the purpose specified in  
17 this act, and that no obligations are incurred in excess of the  
18 sum appropriated. The authority of the allottee to obligate  
19 funds appropriated by this act shall lapse as of September 30,  
20 2008.

21           Section 10. This act shall become law upon approval by the  
22 President of the Federated States of Micronesia or upon its  
23 becoming law without such approval.
