

A BILL FOR AN ACT

To further amend Public Law No. 7-39, as amended, by amending sections 2 and 4 thereof, to change the use and lapse date of certain funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 7-39, as amended by  
2 Public Laws Nos. 12-73, 13-20, 13-34 and 13-82, is hereby further  
3 amended to read as follows:

4 "Section 2. The sum appropriated under section 1 of  
5 this act shall be apportioned as follows:

6 (1) Community and Public Projects:

7 (a) Magachgil, Gilman Community

8 Project .....\$ 70,000

9 (b) Ngolog, Rull Community Project .. 70,000

10 (c) Okau Women's Project ..... 35,000

15 Section 2. Section 4 of Public Law No. 7-39, as amended by  
16 Public Laws No. 12-73 and 13-34, is hereby further amended to read  
17 as follows:

18 "Section 4. Allotment and management of funds and lapse  
19 date.

20 (1) All funds appropriated by this act shall be  
21 allotted, managed, administered, and accounted for in  
22 accordance with applicable law, including, but not  
23 limited to, the Financial Management Act of 1979. The  
24 allottee of the funds appropriated under section 2 of  
25 this act shall be the Governor of Yap State. The

1 allottee shall be responsible for ensuring that these  
2 funds, or so much thereof as may be necessary, are used  
3 solely for the purposes specified in this act, and that  
4 no obligations are incurred in excess of the sum  
5 appropriated.

6 (2) The authority of the allottee to obligate funds  
7 appropriated by this act shall lapse September 30,  
8 ~~[2005]~~-2006."

9 Section 3. This act shall become law upon approval by the  
10 President of the Federated States of Micronesia or upon it  
11 becoming law without such approval.
