

A BILL FOR AN ACT

To further amend Public Law No. 7-35, as amended, by amending section 3 thereof, to change the uses of certain funds, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 7-35, as amended by  
2 Public Laws Nos. 7-44 and 7-70, is hereby further amended to read as  
3 follows:

4 "Section 3. Southern Namoneas public projects.

5 The sum of \$595,000, or so much thereof as may be necessary,  
6 is hereby appropriated from the General Fund of the  
7 Federated States of Micronesia for the fiscal year ending  
8 September 30, 1992, for the purpose of funding public  
9 projects in Southern Namoneas, Chuuk State. The sum  
10 appropriated by this section shall be apportioned as
