

A BILL FOR AN ACT

To further amend Public Law No. 10-120, as amended, by amending section 1 thereof to change the use of certain funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 10-120, as amended by  
2 Public Laws Nos. 10-122, 10-144, 11-8, 11-20, 11-32, 12-6, 12-20,  
3 12-68, 13-11 and 13-31, is hereby further amended to read as  
4 follows:

5 "Section 1. The sum of \$5,000,000, or so much thereof  
6 as may be necessary, is hereby appropriated from the  
7 General Fund of the Federated States of Micronesia for  
8 the fiscal year ending September 30, 1999, for the  
9 purpose of funding infrastructure and other projects and  
10 programs in the State of Chuuk. The funds appropriated  
11 under this section shall be apportioned as follows:

- 12 (1) Regional transportation projects
- 13 (which shall be deemed to come from capital
- 14 account funds available under section 211
- 15 of the Compact of Free Association)
- 16 (a) Ta airport paving and related
- 17 structures and equipment .....\$ 200,000
- 18 (b) Houk airport paving, including
- 19 acquisition of related structures and
- 20 equipment ..... 250,000
