

AN ACT

To further amend Public Law No. 10-143, as amended, by amending sections 1, 3 and 5 thereof to change the use and allottee of certain funds appropriated therein, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 10-143, as amended by  
2 Public Law No. 11-2, is hereby further amended to read as follows:

3 "Section 1. The sum of \$935,162, or so much thereof as  
4 may be necessary, is hereby appropriated from the  
5 General Fund of the Federated States of Micronesia for  
6 the fiscal year ending September 30, 1999, for the  
7 purpose of meeting the needs of primary and secondary  
8 public schools and State hospitals and State-  
9 administered public health programs and funding social  
10 and economic projects or grants in the State of Chuuk.  
11 The funds appropriated herein shall be apportioned as  
12 follows:

11 Section 2. Section 3 of Public Law No. 10-143, as amended by  
 12 Public Laws Nos. 11-3, 12-58 and 14-14, is hereby further amended  
 13 to read as follows:

14 "Section 3. The sum of \$300,000, or so much thereof as  
 15 may be necessary, is hereby appropriated from the  
 16 General Fund of the Federated States of Micronesia for  
 17 the fiscal year ending September 30, 1999, for the  
 18 purpose of meeting the needs of primary and secondary  
 19 public schools and State hospitals and State-  
 20 administered public health programs in the State of Yap.  
 21 The funds appropriated under this section shall be  
 22 disbursed and used for educational, hospital and public  
 23 health purposes, excluding any disbursement for  
 24 salaries, travel (except relating to the APNLC or

19 Section 3. Section 5 of Public Law No. 10-143, as amended by  
 20 Public Laws Nos. 12-22, 12-31 and 12-41, is hereby further amended  
 21 to read follows:

22 "Section 5. Allotment and management of funds and lapse  
 23 date.

24 (1) All funds appropriated by this act shall be  
 25 allotted, managed, administered, and accounted for in

1           accordance with applicable law, including, but not  
2           limited to, the Financial Management Act of 1979. The  
3           allottee of the funds appropriated under section 1(1) of  
4           this act shall be the Executive Director of the Mortlock  
5           Development Commission, or his designee. The allottee  
6           of  
7           the funds appropriated under section 1(2) of this act  
8           shall be the Executive Director of the Northern Namoneas  
9           Development Authority or his designee. The allottee of  
10          the funds appropriated under section 1(3) of this act  
11          shall be the Executive Director of the Chuuk State  
12          Commission on Improvement Projects. The allottee of the  
13          funds appropriated under section 1(4) of this act shall  
14          be the Mayor of Polle. The allottee of the funds  
15          appropriated under section 1(5) of this act shall be the  
16          Northwest Islands Project Coordinator or his designee.  
17          The allottee of the funds appropriated under section  
18          1(6) of this act shall be the Chuuk State Commission on  
19          Improvement Projects. The allottee of the funds  
20          appropriated under section 2(1)(b) of this act shall be  
21          the Mayor of Kolonia. The allottee of the funds  
22          appropriated under section 3 of this act shall be the  
23          Governor of the State of Yap or the Governor's designee  
24          except that the allottee of the funds appropriated under  
25          section 3(6) shall be the President of the Federated

1 States of Micronesia or the President's designee. The  
2 allottee of the funds appropriated under section 4 of  
3 this act shall be the Governor of the State of Kosrae or  
4 the Governor's designee. The allottee of all other  
5 funds appropriated by this act shall be the President of  
6 the Federated States of Micronesia or the President's  
7 designee. The allottees shall be responsible for  
8 ensuring that these funds, or so much thereof as may be  
9 necessary, are used solely for the purpose specified in  
10 this act, and that no obligations are incurred in excess  
11 of the sum appropriated.

12 (2) The authority of the allottees to obligate funds  
13 appropriated by this act shall not lapse."

14 Section 4. This act shall become law upon approval by the  
15 President of the Federated States of Micronesia or upon its  
16 becoming law without such approval.
