

A BILL FOR AN ACT

To appropriate \$490,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2009, for the purpose of funding public projects and social programs in the States of Chuuk, Yap, Pohnpei and Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Public law 15-66 is hereby repealed in its
2 entirety.

3 Section 2. The sum of \$490,000 is hereby appropriated from
4 the General Fund of the Federated States of Micronesia for the
5 fiscal year ending September 30, 2009, for the purpose of funding
6 public projects and social programs in the States of Chuuk, Yap,
7 Pohnpei and Kosrae; and for other purposes. The sum appropriated
8 herein shall be apportioned as follows:

9	(1) <u>State of Kosrae</u>	\$ 70,000
10	(2) <u>State of Yap</u>	70,000
11	(3) <u>State of Pohnpei</u>	140,000
12	(4) <u>State of Chuuk</u>	210,000

13 Section 3. Allotment and management of funds and lapse date.

14 (1) General Provisions.

15 (a) All funds appropriated by this act shall be
16 allotted, managed, administered and accounted for in accordance
17 with applicable law, including, but not limited to, the Financial
18 Management Act of 1979 and the amended Compact of Free Association
19 between the United States Government and the Government of the

1 Federated States of Micronesia and its related agreements.

2 (b) The allottees shall be responsible for
3 ensuring that these funds, or so much thereof as may be
4 necessary, are used solely for the purpose specified in this act,
5 and that no obligations are incurred in excess of the sum
6 appropriated.

7 (2) Allottees. The allottee of the funds appropriated
8 by this act are as follows:

9 (a) Subsection 1 of Section 2 - the allottee of
10 these funds shall be the President of the Federated States of
11 Micronesia or his designee;

12 (b) Subsection 2 of Section 2 - the allottee of
13 these funds shall be the Governor of Yap State or his designee;

14 (c) Subsection 3 of Section 2 - the allottee of
15 these funds shall be the President of the Federated States of
16 Micronesia;

17 (d) Subsection 4 of Section 2 - the allottee of
18 these funds shall be the Chuuk State Commission on Improvement
19 Projects;

20 (3) Lapse Date. The authority of the allottee to
21 obligate funds appropriated by this act shall not lapse until
22 fully expended.

25 Section 4. This act shall become law upon approval by the

1 President of the Federated States of Micronesia or upon its
2 becoming law without such approval.
