Your Committee on Health, Education and Social Affairs ("HESA"), to
which was referred C.R. No. 15-55 entitled:

"A RESOLUTION CONFIRMING THE NOMINATION OF LYNDON L.
CORNELIUS TO BE KOSRAE STATE'S REPRESENTATIVE OR MEMBER ON
THE BOARD OF REGENTS OF THE COLLEGE OF MICRONESIA.",

begs leave to report as follows:

The intent and purpose of the resolution are expressed in its title.

Mr. Lyndon Cornelius has been nominated by the President of the
Federated States of Micronesia to be Kosrae State's representative or
member on the Board of Regents of the College of Micronesia. Title 2,
section 207(1) of the Code of the Federated States of Micronesia sets
out that this nomination is subject to the advice and consent of
Congress.

PUBLIC HEARING

Your committee held a public hearing on the nomination on the
afternoon of Wednesday, November 21, 2007.

The nominee was unable to appear as he was on the island of Kosrae and
had not been able to fly to Pohnpei on time for the hearing.
President James of the College of Micronesia was present to give his
support to the nominee. Chairman Urusemal was present, along with Vice
Chairman Phillip and Senator Halbert.

Mr. Cornelius is well known to all present at the hearing. He is
currently retired, having served previously as an educator, State
Legislator, Associate and Chief Justice Kosrae State Court as well as
Legal Counselor of the Micronesia Legal Services Corporation, Kosrae
office. President James of COM-FSM and others in the hearing gave
clear and strong support to the nomination.
