Dear Mr. Speaker:

Your Committee on Judiciary and Governmental Operations ("J&GO"), to which was referred C.R. No. 15-68 entitled:

"A RESOLUTION CONFIRMING THE NOMINATION OF MR. ISMAEL I. DOBICH TO SERVE AS NATIONAL ELECTION COMMISSIONER FOR CHUUK STATE.",

begs leave to report as follows:

The intent and purpose of the resolution are expressed in its title.

Mr. Ismael I. Dobich has been nominated by the President of the Federated States of Micronesia to serve as the National Election Commissioner for the State of Chuuk. Title 9, section 302(2)(a) of the Code of the Federated States of Micronesia sets out that this nomination is subject to the advice and consent of Congress. Before its own consideration of the nominee, your committee assumes that, as this nomination has been submitted by the President, the President has made a thorough review and screening of the nominee's abilities and qualifications for the position.

Mr. Dobich's curriculum vitae is included in Presidential Communication 15-102 and is summarized here. Mr. Ismael has served as the Chuuk State National Election Commissioner since late May 2007. Previously, he was a manager and coordinator for Pacific Resources for Education and Learning (PREL) in Honolulu, Hawaii and Chief Clerk for the Senate of the Chuuk State Legislature.

Your committee declined to hold a hearing on the nomination, noting that Mr. Dobich is a qualified candidate and has been serving in the position since May. Members are satisfied with his performance up to this point.
