

A BILL FOR AN ACT

To amend Section 1 of Public Law No. 15-80 to change the use of certain funds previously appropriated therein for public projects and social programs in the States of Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 15-80 is hereby
2 amended to read as follows:

3 "Section 1. The sum of \$540,000 is hereby appropriated from
4 the General Fund of the Federated States of Micronesia for the
5 fiscal year ending September 30, 2009, for the purpose of funding
6 the T-3 Program Operation, public projects and social programs in
7 the States of Chuuk, Yap, Pohnpei and Kosrae, and for other
8 purposes. The sum appropriated herein shall be apportioned as
9 follows:
