
A BILL FOR AN ACT

To appropriate from the General Fund of the Federated States of Micronesia the sums of \$55,950 for the Department of Foreign Affairs, \$215,263 for Capacity Building Roadmap of the Department of Finance and Administration, \$400,000 for FSM Development Bank capital for private sector; and from the SEG and Sector Grants pursuant to the amended Compact the sums of \$603,240 for the National Department of Education Integration Plan from the education sector grant, \$9,250,000 for infrastructure projects from the infrastructure sector grant, and \$684,564 for COM-FSM from Supplemental Education Grant; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Appropriation. There is hereby appropriated from
2 the General Fund of the Federated States of Micronesia for the
3 fiscal year 2010 the sum of \$55,950, or so much thereof as may be
4 necessary, to defray the needed operational costs for the
5 Department of Foreign Affairs and its mission offices in
6 Washington D.C., New York, Fiji, China, and Guam.

7 Section 2. Appropriation. There is hereby appropriated from
8 the General Fund of the Federated States of Micronesia for the
9 fiscal year 2010 the sum of \$215,263, or so much thereof as may be
10 necessary, to fund Capacity Building Roadmap for the Department of
11 Finance and Administration to further strengthen the overall
12 capacity of the national government staff.

13 Section 3. Appropriation. There is hereby appropriated from
14 the General Fund of the Federated States of Micronesia for the
15 fiscal year 2010 the sum of \$400,000, or so much thereof as may be

1 necessary, to capital funding of the FSM Development Bank Capital
2 to support private sector.

3 Section 4.Appropriation. There is hereby appropriated from
4 the General Fund of the Federated States of Micronesia for the
5 fiscal year 2010 the sum of \$603,240, or so much thereof as may be
6 necessary, to fund the FSM Department of Education Integration
7 Plan for fiscal year 2010 as approved per JEMCO Resolution 2009-
8 11. The amount hereby appropriated shall be deemed to come from
9 the amended Compact Sector Grant for Education.

10 Section 5.Appropriation. There is hereby appropriated from
11 the General Fund of the Federated States of Micronesia for the
12 fiscal year 2010 the sum of \$9,250,000, or so much thereof as may
13 be necessary, to fund the infrastructure projects for the
14 Federated States of Micronesia and for the development of project
15 scope, design, construction bid package preparation and tender of
16 construction bid packages as concurred in by JEMCO and Office of
17 Insular Affairs. The amount hereby appropriated shall be deemed to
18 come from the amended Compact Sector Grant for Infrastructure.

19 Section 6.Appropriation. There is hereby appropriated from
20 the General Fund of the Federated States of Micronesia for the
21 fiscal year 2010 the sum of \$684,564, or so much thereof as may be
22 necessary, for the College of Micronesia - FSM for its integration
23 plan approved to be funded under Supplemental Education Grant
24 (SEG). The amount hereby appropriated shall be deemed to come from
25 the SEG pursuant to the amended Compact.

1 Section 7. Reprogramming. Funds appropriated in accordance
2 with this act are not subject to reprogramming.

3 Section 8. Allottee. The allottee of the funds appropriated by
4 this act shall be the President of the Federated States of
5 Micronesia.

6 Section 9. Allotment and management of funds and lapse date.
7 All funds appropriated by this act shall be allotted, managed,
8 administered and accounted for in accordance with applicable laws,
9 including, but not limited to, the Financial Management Act of
10 1979, Provided, that, for appropriations pursuant to sections 4,
11 5, and 6 hereof, the terms of the amended Compact and the Fiscal
12 Procedure Agreement shall also apply. The allottee shall be
13 responsible for ensuring that these funds, or so much thereof as
14 may be necessary, are used solely for the purpose specified in
15 this act, and that no obligations are incurred in excess of the
16 sums appropriated.

17 Section 10. Lapse date. The authority of the allottee to
18 obligate all funds appropriated under this act shall lapse as
19 follows:

20 (a) Appropriations pursuant to sections 1, 2, and
21 3 shall lapse as of September 30, 2010.

22 (b) Appropriations pursuant to sections 4, 5, and
23 6 shall lapse as of the date as provided in the grant awards.

1 Section 11. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
