

A BILL FOR AN ACT

To amend Public Law No. 16-58, by amending sections 3 and 4, to modify the use of certain funds previously appropriated to fund public projects and social programs in the States of Yap and Pohnpei for fiscal year 2011, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 3 of Public Law No. 16-58 is hereby
2 amended to read as follows:

5 public projects and social programs.
