

A BILL FOR AN ACT

To amend Public Law No. 16-62 by amending sections 2 and 4 thereof, to modify the use of funds previously appropriated therein to fund public projects and social programs in the States of Kosrae and Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 16-62 is hereby
2 amended to read as follows:
