Your Committee on Ways and Means, to which was referred C.B. No. 16-27, entitled:

"A BILL FOR AN ACT TO APPROPRIATE THE SUM OF \$1,400,000 FROM THE GENERAL FUND OF THE FEDERATED STATES OF MICRONESIA FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2010 FOR THE PURPOSE OF FUNDING ECONOMIC AND SOCIAL PROJECTS AND PROGRAMS IN THE STATES OF YAP, KOSRAE, POHNPEI AND CHUUK, AND FOR OTHER PURPOSES.",

begs leave to report as follows:

The intent and purpose of the bill are expressed in its title.

C.B. No. 16-27 was introduced during the first special session of the 16th Congress. The intent of the bill is to appropriate a sum of \$1.4 million from the General Fund of the Federated States of Micronesia for fiscal year 2010 to fund public projects and social programs in each of the states. To date, Congress is reluctant to take any action on the bill because the revenue projection for fiscal year 2010 is lower than \$1.4 million.

On November 12, 2009, the Secretary of the Department of Finance and Administration transmitted to Congress a revised and updated revenue projection for fiscal year 2010. The available fund balance in domestic revenue that is available for appropriation is \$2,023,793.

Your Committee wishes to take action on C.B. No. 16-27 this session. However, after further review of C.B. No. 16-27, your Committee proposes the following amendments to C.B. No. 16-27:

With all the proposed amendments to this bill, the actual amount that is proposed for public projects and social program for each state is \$1,820,000, which is less than \$2,023,793 (the available fund balance in domestic revenue).
