

A RESOLUTION

Confirming the nomination of Mr. Florencio (Singkoro) Harper to serve as a member of the Board of Directors for Caroline Island Air (CIA), pursuant to Public Law No. 10-72, as amended by Public Law No. 16-26.

1           WHEREAS, under Section 6 of Public Law No. 10-72, as amended  
2 by Public Law No. 16-26, the Board of Directors for Caroline  
3 Island Air (CIA) shall consist of five (5) voting members and one  
4 ex-officio non-voting member. One member of the Board shall be a  
5 representative of the National Government, and there shall be one  
6 representative from each State of the Federated States of  
7 Micronesia, who shall be recommended by the Governor of the  
8 relevant State, and shall serve a period of three years; and

9           WHEREAS, under Section 6 of Public Law No. 10-72, as amended  
10 by Public Law No. 16-26, the President of the Federated States of  
11 Micronesia shall appoint members to the Board of Directors of  
12 Caroline Island Air (CIA) with the advice and consent of Congress;  
13 and

14           WHEREAS, pursuant to the recommendation made by the Governor  
15 of the State of Chuuk, the President nominated Mr. Florencio  
16 (Singkoro) Harper to represent the State of Chuuk on the Board of  
17 Directors of Caroline Island Air (CIA) for a period of three  
18 years; and

19           WHEREAS, Mr. Florencio (Singkoro) Harper is currently the  
20 Speaker of the House of Representatives in the Chuuk State Legislature; and

21           WHEREAS, Mr. Harper holds relative experience and

1 qualifications which make him a suitable candidate to serve as a  
2 member of the Board of Directors for Caroline Island Air (CIA);  
3 and

4 WHEREAS, the nomination of Mr. Florencio (Singkoro) Harper  
5 is subject to the advice and consent of the Congress of the  
6 Federated States of Micronesia; now, therefore,

7 BE IT RESOLVED by the Sixteenth Congress of the Federated  
8 States of Micronesia, Fifth Regular Session, 2010, that the  
9 nomination of Mr. Florencio (Singkoro) Harper to serve as a Member  
10 of the Board of Directors for Caroline Island Air (CIA), is hereby  
11 confirmed; and

12 BE IT FURTHER RESOLVED that certified copies of this  
13 resolution be transmitted to the President of the Federated States  
14 of Micronesia, the Governor of the State of Chuuk, the Board of  
15 Directors of Caroline Island Air (CIA), and Mr. Florencio  
16 (Singkoro) Harper.
