

A RESOLUTION

Confirming the nomination of Ms. Suzanne L. Gallen as a member of the Joint Economic Management Committee created and in existence pursuant to the Fiscal Procedure Agreement between the Government of the Federated States of Micronesia and the Government of the United States of America for the implementation of section 213 of the Compact of Free Association, amended.

1 WHEREAS, Article III, Section 1, of the Fiscal Procedure
2 Agreement, hereinafter referred to as the "Agreement", established
3 the Joint Economic Management Committee; and

4 WHEREAS, Article III, Section 2, of the Agreement provides
5 that the Joint Economic Management Committee shall be composed of
6 five members, three of whom, including the chairman, shall be
7 appointed by the Government of the United States of America, and
8 the remaining two members shall be appointed by the Government of
9 the Federated States of Micronesia; and

10 WHEREAS, under Public Law No. 15-70, Section 2(1)(a) and (b),
11 the President shall appoint one FSM representative on the Joint
12 Economic Management Committee from a position within the FSM
13 National Government, and the other representative from a list of
14 four nominees, one nominee per State Governor; and that the
15 Appointment is subject to the advice and consent of the Congress
16 of the Federated States of Micronesia; and

1 WHEREAS, under Public Law No. 15-70, Section 2(1)(b), the
2 President of the Federated States of Micronesia hereby appoints
3 Ms. Suzanne L. Gallen to be a representative of the Federated
4 States of Micronesia on the Joint Economic Management Committee
5 from within a list of four nominees, one nominee from each State
6 Governor; and

7 WHEREAS, Ms. Suzanne L. Gallen has been appointed based,
8 *inter alia*, on her outstanding educational achievements coupled
9 with her experience in management, her current position as
10 Assistant Secretary, Division of Compact Management, and numerous
11 other outstanding credentials; and

12 WHEREAS, confirmation of the appointment of Ms. Suzanne L.
13 Gallen as a representative of the Federated States of Micronesia
14 on the Joint Economic Management Committee will be in the best
15 interest of this Nation; now, therefore,

16 BE IT RESOLVED by the Sixteenth Congress of the Federated
17 States of Micronesia, Fifth Regular Session, 2010, that the
18 nomination of Ms. Suzanne L. Gallen as one of the representatives
19 of the Federated States of Micronesia on the Joint Economic
20 Management Committee, established and in existence pursuant to
21 Article III, Section 1, of the Fiscal Procedure Agreement between
22 the Government of the Federated States of Micronesia and the
23 Government of the United States of America, under the amended
24 Compact of Free Association, and pursuant to Public Law No. 15-70,
25 Section 2, is hereby confirmed; and

1 BE IT FURTHER RESOLVED that certified copies of this
2 resolution be transmitted to the President of the Federated States
3 of Micronesia, the Secretary of the FSM Department of Foreign
4 Affairs and Ms. Suzanne L. Gallen.
