

A BILL FOR AN ACT

To further amend Public Law No. 17-19, as amended by Public Laws Nos. 17-28 and 17-31, by amending section 3 thereof, to change the use of funds previously appropriated for the fiscal year ending September 30, 2012, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 3 of Public Law No. 17-19, as amended  
2 by Public Laws Nos. 17-28 and 17-31, is hereby amended to read  
3 as follows:

4               "Section 3. Operating Expenses of the Legislative  
5               Branch. The sum of \$3,325,228, or so much thereof  
6               as may be necessary, is hereby appropriated from the  
7               General Fund of the Federated States of Micronesia  
8               for the fiscal year ending September 30, 2012, for  
9               the operations of the Legislative Branch of the  
10              National Government during fiscal year 2012. The  
11              sum appropriated by this section shall be  
12              apportioned as follows:

13              (1) Speaker and Members.

14              The sum of \$1,490,771, or so much thereof as may be  
15              necessary, for the operations of the Office of the  
16              Speaker and Members of the Congress of the Federated  
17              States of Micronesia during fiscal year 2012. The  
18              sum appropriated herein shall be apportioned as  
19              follows:

1	Personnel .....	\$ 423,290
2	Travel .....	489,881
3	Contractual Services .....	507,600
4	OCE .....	70,000
5	Fixed Assets .....	-0-

6 (2) Staff Offices.

7 The sum of \$ [~~1,344,457~~] 1,328,957, or so much thereof  
 8 as may be necessary, for the operations of the  
 9 Congress staff offices during fiscal year 2012. The  
 10 sum appropriated herein shall be apportioned as  
 11 follows:

12	Personnel .....	\$ 844,705
13	Travel .....	128,252
14	Contractual Services .....	[ <del>210,500</del> ] <u>195,000</u>
15	OCE .....	127,000
16	Fixed Assets .....	34,000

17 (3) Congress Delegation Offices.

18 The sum of \$ [~~490,000~~] 505,500, or so much thereof as  
 19 may be necessary, for the operations of the Congress  
 20 delegation offices during fiscal year 2012. Of the  
 21 amounts appropriated for contractual services within  
 22 each Delegation Office, up to a maximum of \$25,000  
 23 per Member, at the Delegation Offices' discretion,  
 24 may be used for Member Representation. The sum  
 25 appropriated is apportioned as follows:
