

A BILL FOR AN ACT

To appropriate the sum of \$5,697,383 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2013, for the purpose of paying the amount owed by the State Governments to FEMA and to fund public projects and social programs in the States of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$5,697,383, or so much thereof as may  
2 be necessary, is hereby appropriated from the General Fund of the  
3 Federated States of Micronesia for the fiscal year ending  
4 September 30, 2013, for the purpose of paying the amount owed by  
5 the State Governments to FEMA and to fund public projects and  
6 social programs in the States of Yap, Kosrae, Pohnpei and Chuuk.  
7 The funds appropriated under this section shall be apportioned as  
8 follows:

9 Section 2. Of the sum of \$5,697,383 appropriated by this  
10 act, \$284,210 is apportioned to pay the amount owed by the State  
11 of Yap to FEMA and \$600,000 is apportioned for public projects and  
12 social programs in the State of Yap.

15 Section 3. Of the sum of \$5,697,383 appropriated by this  
16 act, \$15,197 is apportioned to pay the amount owed by the State  
17 of Kosrae to FEMA and \$600,000 is apportioned for public  
18 projects and social programs in the State of Kosrae.

3           Section 4. Of the sum of \$5,697,383 appropriated by this  
 4 act, \$219,116 is apportioned to pay the amount owed by the  
 5 State of Pohnpei to FEMA and \$1,200,000 is apportioned for  
 6 public projects and social programs in the State of Pohnpei.

14           Section 5. Of the sum of \$5,697,383 appropriated by this  
 15 act, \$978,860 is apportioned to pay the amount owed by the State  
 16 of Chuuk to FEMA and \$1,800,000 is apportioned for public projects  
 17 and social programs.

1           Section 6. Allotment and management of funds and lapse  
2 date. All funds appropriated by this act shall be allotted,  
3 managed, administered and accounted for in accordance with  
4 applicable laws, including, but not limited to, the Financial  
5 Management Act of 1979. The allottee shall be responsible for  
6 ensuring that these funds, or so much thereof as may be  
7 necessary, are used solely for the purpose specified in this  
8 act, and that no obligations are incurred in excess of the sum  
9 appropriated. The allottee of the funds appropriated under  
10 section 2 of this act shall be the Governor of Yap State. The  
11 allottee of funds appropriated under sections 3 and 4 of this  
12 act shall be the President of the Federated States of  
13 Micronesia or his designee, EXCEPT THAT the allottee of funds  
14 appropriated under subsection 1 of section 3 of this act shall  
15 be the Governor of Kosrae State and the allottee of funds  
16 appropriated under subsection 1 of section 4 of this act shall  
17 be the Governor of Pohnpei State. The allottee of funds  
18 appropriated under subsections 5(1), 5(2)(a) and 5(2)(f) of  
19 this act shall be the Governor of Chuuk State or his designee.  
20 The allottee of funds appropriated under subsection 5(b) of  
21 section 5 of this act shall be the Mortlock Islands Development  
22 Authority. The allottee of funds appropriated under subsection  
23 5(c) of section 5 of this act shall be the Executive Director  
24 of the Northern Namoneas Social and Economic Development  
25 Authority or his designee. The allottee of funds appropriated

1 under subsection 5(d) of section 5 of this act shall be the  
2 Faichuk Development Authority. The allottee of funds  
3 appropriated under subsection 5(e) of section 5 of this act  
4 shall be the Southern Namoneas Development Authority. The  
5 authority of the allottee to obligate funds appropriated by  
6 this act shall lapse on September 30, 2014.

7 Section 7. This act shall become law upon approval by the  
8 President of the Federated States of Micronesia or upon its  
9 becoming law without such approval.
