
A BILL FOR AN ACT

To further amend section 6 of Public Law No. 17-48, as amended by Public Law No. 17-46, to change the allottee of certain funds previously appropriated to fund public projects and social programs in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 17-36, as amended
2 by Public Law No. 17-48, is hereby further amended to read as
3 follows:

4 "Section 6. Allotment and management of funds and lapse
5 date. All funds appropriated by this act shall be allotted,
6 managed, administered and accounted for in accordance with
7 applicable laws, including, but not limited to, the Financial
8 Management Act of 1979. The allottee shall be responsible for
9 ensuring that these funds, or so much thereof as may be
10 necessary, are used solely for the purpose specified in this
11 act, and that no obligations are incurred in excess of the sum
12 appropriated. The allottee of the funds appropriated under
13 section 2 of this act shall be the Governor of Yap State. The
14 allottee of funds appropriated under sections 3 and 4 of this
15 act shall be the President of the Federated States of
16 Micronesia or his designee, EXCEPT THAT the allottee of funds
17 appropriated under subsections 4(3) (a) and (b) of section 4 of
18 this act shall be the Pohnpei Transportation Authority. The
19 allottee of funds appropriated under subsection[s] 5(1) [~~and~~

1 ~~5(6)]~~ of section 5 of this act shall be the Governor of Chuuk
2 State or his designee. ~~[and the allottee of funds appropriated~~
3 ~~under subsection 5(6)(f) shall be the President of COM-FSM.]~~
4 The allottee of funds appropriated under subsection 5(2) of
5 section 5 of this act shall be the Mortlock Islands Development
6 Authority; the allottee of funds appropriated under subsection
7 5(3) of section 5 of this act shall be the Executive Director
8 of the Northern Namoneas Social and Economic Development
9 Authority; the allottee of funds appropriated under subsections
10 5(4) and 5(5) of section 5 of this act shall be the Chuuk State
11 Commission on Improvement Projects (CSCIP). The allottee of
12 funds appropriated under subsection 5(6) of section 5 of this
13 act shall be the Northwest Development Authority or his
14 designee, EXCEPT THAT the allottee of funds appropriated under
15 subsection 5(6)(f) of section 5 of this act shall be the
16 President of COM-FSM. The authority of the allottee to obligate
17 funds appropriated by this act shall lapse on September 30,
18 2014.

19 Section 2. This act shall become law upon approval by the
20 President of the Federated States of Micronesia or upon its
21 becoming law without such approval.
