
A BILL FOR AN ACT

To further amend section 6 of Public Law No. 17-36, as amended by Public Law No. 17-48, to change the allottee of certain funds previously appropriated to fund public projects and social programs in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 17-36, as amended
2 by Public Law No. 17-48, is hereby further amended to read as
3 follow:

4 "Section 6. Allotment and management of funds and lapse
5 date. All funds appropriated by this act shall be
6 allotted, managed, administered and accounted for in
7 accordance with applicable laws, including, but not
8 limited to, the Financial Management Act of 1979. The
9 allottee shall be responsible for ensuring that these
10 funds, or so much thereof as may be necessary, are used
11 solely for the purpose specified in this act, and that
12 no obligations are incurred in excess of the sum
13 appropriated. The allottee of the funds appropriated
14 under section 2 of this act shall be the Governor of Yap
15 State. The allottee of funds appropriated under
16 sections 3 and 4 of this act shall be the President of
17 the Federated States of Micronesia or his designee,
18 EXCEPT THAT the allottee of funds appropriated under
19 subsections 4(3) (a) and (b) of section 4 of this act

1 shall be the Pohnpei Transportation Authority. The
2 allottee of funds appropriated under subsections 5(1)
3 and 5(6) of section 5 of this act shall be the Governor
4 of Chuuk State or his designee and the allottee of funds
5 appropriated under subsection 5(6)(f) shall be the
6 President of COM-FSM. The allottee of funds
7 appropriated under subsection 5(2) of section 5 of this
8 act shall be the Mortlock Islands Development Authority;
9 the allottee of funds appropriated under subsection 5(3)
10 of section 5 of this act shall be the Executive Director
11 of the Northern Namoneas Social and Economic Development
12 Authority; the allottee of funds appropriated under
13 subsections 5(4) [~~and 5(5)~~] of section 5 of this act
14 shall be the Southern Namoneas Development Authority
15 [~~Chuuk State Commission on Improvement Projects~~
16 ~~(CSCIP)~~]. The allottee of funds appropriated under
17 subsection 5(5) of section 5 of this act shall be the
18 Faichuk Development Authority. The authority of the
19 allottee to obligate funds appropriated by this act
20 shall lapse on September 30, 2014.”

1 President of the Federated States of Micronesia or upon its
2 becoming law without such approval.
