

A BILL FOR AN ACT

To further amend section 4 of Public Law No. 17-59, as amended by Public Law No. 17-63, to modify the use of certain funds previously appropriated for the purpose of funding public projects and social programs in the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 17-59, as amended by  
2 Public Law No. 17-63, is hereby further amended to read as  
3 follows:

4 "Section 4. Of the sum of \$1,260,000 appropriated by  
5 this act, \$360,000 is apportioned for Pohnpei State for  
6 public projects and social programs.
