

A BILL FOR AN ACT

To further amend sections 4 and 6 of Public Law No. 17-36, as amended by Public Laws Nos. 17-48 and 17-78, to change the use and allottee of certain funds previously appropriated to fund public projects and social programs in the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 17-36, as amended
2 by Public Law No. 17-48, is hereby further amended to read as
3 follows:

4 "Section 4. Of the sum of \$2,100,000 appropriated by
5 this act, \$600,000 is apportioned for Pohnpei State
6 for public projects and social programs.

1 Section 2. Section 6 of Public Law No. 17-36, as amended
2 by Public Law No. 17-78, is hereby further amended to read as
3 follows:

4 "Section 6. Allotment and management of funds and
5 lapse date. All funds appropriated by this act shall
6 be allotted, managed, administered and accounted for
7 in accordance with applicable laws, including, but
8 not limited to, the Financial Management Act of 1979.
9 The allottee shall be responsible for ensuring that
10 these funds, or so much thereof as may be necessary,
11 are used solely for the purpose specified in this
12 act, and that no obligations are incurred in excess
13 of the sum appropriated. The allottee of the funds
14 appropriated under section 2 of this act shall be the
15 Governor of Yap State. The allottee of funds
16 appropriated under sections 3 and 4 of this act shall
17 be the President of the Federated States of
18 Micronesia or his designee, EXCEPT THAT the allottee
19 of funds appropriated under subsections 4(1)(b), 4(3)
20 (a) and (b) of section 4 of this act shall be the
21 Pohnpei Transportation Authority. The allottee of
22 funds appropriated under subsection 5(1) of section 5
23 of this act shall be the Governor of Chuuk State or
24 his designee. The allottee of funds appropriated
25 under subsection 5(2) of section 5 of this act shall

1 be the Mortlock Islands Development Authority; the
2 allottee of funds appropriated under subsection 5(3)
3 of section 5 of this act shall be the Executive
4 Director of the Northern Namoneas Social and Economic
5 Development Authority; the allottee of funds
6 appropriated under subsections 5(4) of section 5 of
7 this act shall be the Southern Namoneas Development
8 Authority. The allottee of funds appropriated under
9 subsection 5(5) of section 5 of this act shall be the
10 Faichuk Development Authority. The allottee of funds
11 appropriated under subsection 5(6) of section 5 of
12 this act shall be the Northwest Development Authority
13 (NWDA), PROVIDED THAT the allottee of the funds
14 appropriated under subsection 5(6)(f) shall be the
15 President of COM-FSM. The authority of the allottee
16 to obligate funds appropriated by this act shall
17 lapse on September 30, 2014."

18 Section 3. This act shall become law upon approval by the
19 President of the Federated States of Micronesia or upon its
20 becoming law without such approval.
