

A BILL FOR AN ACT

To further amend Public Law No. 16-62, as amended by Public Laws Nos. 16-71 and 17-05, by amending sections 4, 5 and 6 thereof, to change the use and allottee of certain funds previously appropriated therein to fund public projects and social programs in the States of Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 16-62, as amended by
2 Public Laws Nos. 16-71 and 17-05, is hereby further amended to
3 read as follows:

4 "Section 4. Of the sum of \$1,050,000 appropriated by
5 this act, \$300,000 is apportioned for Pohnpei State for
6 public projects and social programs.

 12 this act, \$450,000 is apportioned for Chuuk State for
 13 public projects and social programs.

13 Section 3. Section 6 of Public Law No. 16-62, as amended
14 by Public Law No. 17-05, is hereby further amended to read as
15 follows:

16 "Section 6. Allotment and management of funds and
17 lapse date. All funds appropriated by this act shall
18 be allotted, managed, administered and accounted for
19 in accordance with applicable law, including, but not
20 limited to, the Financial Management Act of 1979.
21 The allottee shall be responsible for ensuring that
22 these funds, or so much thereof as may be necessary,
23 are used solely for the purpose specified in this
24 act, and that no obligations are incurred in excess
25 of the sum appropriated. The allottee of funds

1 appropriated under sections 2 and 4 of this act shall
2 be the President of the Federated States of
3 Micronesia or his designee, PROVIDED THAT the
4 allottee of funds appropriated under subsection
5 4(1)(c) of this act shall be the Pohnpei
6 Transportation Authority, [F] the allottee of funds
7 appropriated under subsection 4(2)(c) of this act
8 shall be the Secretary of the Department of Resources
9 and Development or his designee, the allottee of
10 funds appropriated under subsections 4(3)(b), 4(3)(c)
11 and 4(3)(j) of this act shall be the Luhkenmoanlap of
12 Kitti Municipal Government and the allottee of funds
13 appropriated under subsection 4(3)(i) of this act
14 shall be the Meninkeder Lapalap of Madolenihmw
15 Municipal Government. The allottee of funds
16 appropriated under section 3 of this act shall be the
17 Governor of Yap State. The allottee of funds
18 appropriated under subsections 5(1)(2)(4)(5) and (6)
19 shall be the Chuuk State Commission on Improvement
20 Project (CSCIP). The allottee of funds appropriated
21 under subsection 5(3) of this act shall be the
22 Executive Director of the Northern Namoneas Social
23 and Economic Development Authority. The funds
24 appropriated by this act shall remain available until
25 fully expended."

1 Section 4. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
