Dear Mr. Speaker:

Your Committee on Ways and Means, to which was referred C.B. No. 17-25, entitled:

"A BILL FOR AN ACT TO AMEND SECTIONS 4 AND 6 OF PUBLIC LAW NO. 16-49, BY CHANGING THE USE AND ALLOTTEE OF CERTAIN FUNDS PREVIOUSLY APPROPRIATED THEREIN FOR THE PURPOSE OF FUNDING PUBLIC PROJECTS AND SOCIAL PROGRAMS IN THE STATE OF POHNPEI, AND FOR OTHER PURPOSES.",

begs leave to report as follows:

The intent and purpose of the bill are expressed in its title.

Under section 4 of Public Law No. 16-49, as amended, some funding for public projects and social programs for Pohnpei State has not been allotted and expended. According to the advice from the Office of SBOC, this funding is still available, and shall remain available until fully expended. Section 6 concerns the allotment and management of the funds and the lapse date.

One of the intentions of C.B. No. 17-25 is to take "\$8,000" from the "Kapinga Youth" line item under Election District No. 1,
