Your Committee on Judiciary and Governmental Operations
("J&GO"), to which was referred C.R. No. 17-75, entitled:

"A RESOLUTION TO CONFIRM THE NOMINATION OF
MR. NICKSON BOSSY TO SERVE AS THE FSM
NATIONAL ELECTION COMMISSIONER FOR CHUUK
STATE.",

The intent and purpose of the resolution are expressed in
its title.

Mr. Nickson Bossy has been nominated by the President for
the position of FSM National Election Commissioner for Chuuk
State. This nomination is subject to the advice and consent
of Congress pursuant to article X, section 2(d), of the
Constitution and title 9, section 301 of the Code of the
Federated States of Micronesia.

Your Committee has received a letter from the nominee via the National Election Commissioner expressing his willingness to serve in the position. The nominee's resume indicates he worked as Executive Director of the Chuuk State Election Commission before serving two terms in the Chuuk State Legislature. At a hearing on the nomination held in Palikir on January 26, 2012, the National Election Director spoke in support of the nomination, indicating that he believed that the nominee met the requirements for the position.

Your Committee is satisfied with the qualifications, experience, and dedication of the nominee, and has received no comments in opposition to the nomination.

Your Committee would like to offer the following technical amendment to C.R. No. 17-75:

- Page 1, line 11, delete "Second Special Session, 2011" and insert "Third Regular Session, 2012" in lieu thereof.

Your Committee on Judiciary and Governmental Operations is in accord with the intent and purpose of C.R. No. 17-75, and recommends its adoption in the form attached hereto as C.R. No. 17-75, C.D.1.
