

A BILL FOR AN ACT

To appropriate \$260,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2014, for the purpose of supporting the efforts of the 8th Micronesian Games Organizing Committee, by amending Public Law No. 18-55, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Purpose. The sum of \$ [~~400,000~~] 660,000, or so
2 much thereof as may be necessary, is hereby appropriated from
3 the General Fund of the Federated States of Micronesia for the
4 fiscal year ending September 30, 2014, for the purpose of
5 providing funding for the athletes and coaches from the four
6 States to participate in the 2014 Micronesian Games and
7 international cultural festivals, and to support the efforts of
8 the 8th Micronesian Games Organizing Committee. The funds shall
9 be apportioned as follows:

10	(1) State of Yap.....	\$	100,000
11	(2) State of Kosrae.....		100,000
12	(3) State of Pohnpei.....		
13	<u>(a) to provide funding for the athletes and</u>		
14	<u>coaches</u>		100,000
15	<u>(b) to support the efforts of the 8th</u>

17	(4) State of Chuuk.....		100,000"

18 Section 2. Allotment and management of funds and lapse

1 date. All funds appropriated by this act shall be allotted,
2 managed, administered and accounted for in accordance with
3 applicable laws, including, but not limited to, the Financial
4 Management Act of 1979. The allottee shall be responsible for
5 ensuring that these funds, or so much thereof as may be
6 necessary, are used solely for the purpose specified in this
7 act, and that no obligations are incurred in excess of the sum
8 appropriated. The allottee of the funds appropriated under
9 subsection 1(1) of this act shall be the Governor of the State
10 of Yap or his designee. The allottee of funds appropriated
11 under subsection 1(2) of this act shall be the Governor of the
12 State of Kosrae or his designee. The allottee of funds
13 appropriated under subsection 1(3) (a) of this act shall be the
14 Governor of the State of Pohnpei or his designee. The allottee
15 of funds appropriated under subsection (1)(3)(b) of this act
16 shall be the President of the Federated States of Micronesia or
17 his designee. The allottee of funds appropriated under
18 subsection 1(4) of this act shall be the Governor of the State
19 of Chuuk or his designee. The authority of the allottee to
20 obligate funds appropriated by this act shall lapse on
21 September 30, 2014.

3 becoming law without such approval.
