

A BILL FOR AN ACT

To appropriate the sum of \$2,800,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2015, for the purpose of funding public projects and social programs in each of the four states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$2,800,000, or so much thereof as
2 may be necessary, is hereby appropriated from the General Fund
3 of the Federated States of Micronesia for the fiscal year
4 ending September 30, 2015, for the purpose of funding public
5 projects and social programs in each of the four states. The
6 fund shall be apportioned as follows:

7 Section 2. Of the sum of \$2,800,000 appropriated by this
8 act, \$400,000 is apportioned for Yap State for public projects
9 and social programs.

10 (1) State of Yap \$ 400,000

11 Section 3. Of the sum of \$2,800,000 appropriated by
12 this act, \$400,000 is apportioned for Kosrae State for
13 public projects and social programs.

14 (1) State of Kosrae..... \$ 400,000

15 Section 4. Of the sum of \$2,800,000 appropriated by this
16 act, \$800,000 is apportioned for Pohnpei State for public
17 projects and social programs.

18 State of Pohnpei..... \$ 800,000

4 Section 5. Of the sum of \$2,800,000 appropriated by this
 5 act, \$1,200,000 is apportioned for Chuuk State for public
 6 projects and social programs.

14 Section 6. Allotment and management of funds and lapse
 15 date. All funds appropriated by this act shall be allotted,
 16 managed, administered and accounted for in accordance with
 17 applicable laws, including, but not limited to, the Financial
 18 Management Act of 1979. The allottee shall be responsible for
 19 ensuring that these funds, or so much thereof as may be
 20 necessary, are used solely for the purpose specified in this
 21 act, and that no obligations are incurred in excess of the sum
 22 appropriated. The allottee of the funds appropriated under
 23 section 2 of this act shall be the Governor of Yap State. The
 24 allottee of funds appropriated under sections 3 and 4 of this
 25 act shall be the President of the Federated States of
 26 Micronesia or his designee. The allottee of funds appropriated

1 under subsections 5(1) and 5(3) of this act shall be the
2 Governor of Chuuk State or his designee. The allottee of funds
3 appropriated under subsection 5(2) of section 5 of this act
4 shall be the Mortlock Islands Development Authority. The
5 allottee of funds appropriated under subsection 5(4) of section
6 5 of this act shall be the Faichuk Development Authority. The
7 allottee of funds appropriated under subsection 5(5) of section
8 5 of this act shall be the Southern Namoneas Development
9 Authority. The allottee of funds appropriated under subsection
10 5(6) of this act shall be the Northwest Island Development
11 Authority. The authority of the allottee to obligate funds
12 appropriated by this act shall lapse on September 30, 2016.

13 Section 7. This act shall become law upon approval by the
14 President of the Federated States of Micronesia or upon its
15 becoming law without such approval.
