

A BILL FOR AN ACT

To further amend Public Law No. 19-60, as amended by Public Law No. 19-71, by amending sections 4 and 6 thereof, to change the use and allottee of certain funds previously appropriated therein, for the purpose of funding essential government functions, programs, projects and activities in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 2. Section 4 of Public Law No. 19-60, as amended by
2 Public Law No. 19-71, is hereby further amended to read as
3 follows:

4 "Section 4. Of the sum of \$1,600,000 appropriated by
5 this act, \$500,000 is apportioned to fund essential
6 government functions, programs and activities in the
7 state of Pohnpei.

11 Section 2. Section 6 of Public Law No. 19-60, as amended by
 12 Public Law No. 19-71, is hereby further amended to read as
 13 follows:

14 "Section 6. Allotment and management of funds and
 15 lapse date. All funds appropriated by this act shall
 16 be allotted, managed, administered and accounted for
 17 in accordance with applicable laws, including, but
 18 not limited to, the Financial Management Act of 1979.
 19 The allottee shall be responsible for ensuring that
 20 these funds, or so much thereof as may be necessary,
 21 are used solely for the purpose specified in this
 22 act, and that no obligations are incurred in excess
 23 of the sum appropriated. The allottee of the funds
 24 appropriated under section 2 of this act shall be the
 25 Governor of the State of Yap or his designee. The

1 allottee of the funds appropriated under section 3 of
2 this act shall be the Governor of the State of Kosrae
3 or his designee. The allottee of the funds
4 appropriated under section 4 of this act shall be the
5 Governor of the State of Pohnpei or his designee;
6 PROVIDED THAT, the allottee of the fund appropriated
7 under subsections 4(3)(a), 4(3)(c), 4(4)(a), 4(4)(b)
8 and 4(4)(c) shall be the Pohnpei Transportation
9 Authority (PTA). The [~~allottee of funds appropriated~~
10 ~~under subsection 4(3)(c) shall be the Governor of~~
11 ~~Pohnpei State; the~~] allottee of funds appropriated
12 under section 4(2) of this act shall be the Secretary
13 of Transportation, Communications and Infrastructure
14 or his designee. The allottee of the funds
15 appropriated under section 5 of this act shall be the
16 Governor of the State of Chuuk or his designee. The
17 authority of the allottee to obligate funds
18 appropriated by this act shall lapse on September 30,
19 2017.”
