

A BILL FOR AN ACT

To further amend Public Law No. 18-99, as amended by Public Laws Nos. 18-106, 18-113, 18-121 and 19-05, by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs for the people of the State of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 18-99, as amended by  
2 Public Law No. 18-113, 18-121 and 19-05, is hereby amended to read  
3 as follow:

4 "Section 4. Of the \$2,800,000 appropriated in this act,  
5 \$800,000 is appropriated for public projects and social  
6 programs for the people of the State of Pohnpei.

9 Section 2. Section 6 of Public Law No. 18-99, as amended by  
 10 Public Laws Nos. 18-113, 18-121 and 19-05, is hereby further amended  
 11 to read as follows:

12 "Section 6. Allotment and management of funds and lapse  
 13 date. All funds appropriated by this act shall be  
 14 allotted, managed, administered and accounted for in  
 15 accordance with applicable laws, including, but not  
 16 limited to, the Financial Management Act of 1979. The  
 17 allottee shall be responsible for ensuring that these  
 18 funds, or so much thereof as may be necessary, are used  
 19 solely for the purpose specified in this act, and that  
 20 no obligations are incurred in excess of the sum  
 21 appropriated. The allottee of the funds appropriated  
 22 under section 2 of this act shall be the Governor of Yap  
 23 State or his designee. The allottee of funds  
 24 appropriated under section 3 shall be the President or  
 25 his designee, EXCEPT THAT the allottee of funds

1           appropriated under section 3(a), (b), (c), (d), (e),  
2           (f), (g), (h), (i), (j), (k), (l), (m), (n), (o) and (u)  
3           shall be the Mayor of Lelu Town Government. The  
4           allottee of funds appropriated under section 4 of this  
5           act shall be the President or his designee, EXCEPT that  
6           the allottee of funds appropriated under section 4(1)(a)  
7           shall be the Secretary of the Department of Education;  
8           the allottee of funds appropriated under sections  
9           4(1)(c), 4(1)(e), [~~and~~] 4(1)(h) and 4(2) shall be  
10          Secretary of the Department of Transportation,  
11          Communications and Infrastructure; the allottee of funds  
12          appropriated under section 4(1)(d) shall be the Pohnpei  
13          Port Authority; the allottee of funds appropriated under  
14          section 4(1)(f) shall be the Nett District Government;  
15          the allottee of funds appropriated under section 4(1)(g)  
16          shall be the Secretary of the Department of Resources  
17          and Development; [~~the allottee of funds appropriated~~  
18          ~~under section 4(2)(b) shall be the Mayor of Kapinga~~  
19          ~~Municipal Government~~]; the allottee of funds  
20          appropriated under sections 4(3)(b) and 4(4)(a) shall be  
21          the Pohnpei Transportation Authority and the allottee of  
22          funds appropriated under section 4(3)(g) shall be the  
23          COM-FSM Cooperative Extension Service. The allottee of  
24          funds appropriated under sections 5(1), 5(3) and 5(6) of  
25          this act shall be the Governor of Chuuk State or his
