When Congress took action on his nomination during the First Special Session of Congress, the nominee did not receive the required number of votes.

On August 17, 2015, during the same session, Congress adopted C.R. No. 19-81, which is a resolution authorizing the President to resubmit the nomination of Mr. Wilson Waguk to serve as the Deputy Chief of Mission at the Embassy in Fiji.

On August 31, 2015, the President transmitted the said resolution to Congress through Presidential Communication No. 19-147. Attached with the communication is the nominee's resume.

Your Committee has not received any communication that would cast doubt on the performance or integrity of this nominee. Absent any contrary indication, your Committee believes this nominee should be confirmed, and so recommends Mr. Wilson Waguk be confirmed as the Deputy Chief of Mission at the Embassy in Fiji.

Your Committee on External Affairs is in accord with the intent and purpose of C.R. No. 19-101, and recommends its adoption in the form attached hereto.
