CONGRESSIONAL BILL NO. 3-229, C.D.1,

AN ACT

To further amend Public Law No. 3-18, as amended by Public Laws Nos. 3-39, 3-41, and 3-42, by amending section 1 to reapportion funds appropriated for the operating expenses of the Department of Finance and the Attorney General's Office; to appropriate supplemental funds in the amount of \$10,000 for the Department of Finance to defray expenses incurred by the Plebiscite Commission; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 3-18, as amended by  
2 Public Law No. 3-39, is hereby further amended to read as follows:

3 "Section 1. Operating expenses of the executive branch.

4 The sum of \$1,032,100, or so much thereof as may be  
5 necessary, is hereby appropriated from the General Fund  
6 of the Federated States of Micronesia, and the sum of  
7 \$4,727,115, or so much thereof as may be necessary, is  
8 hereby appropriated from the United States Grant Special  
9 Fund for the fiscal year ending September 30, 1984, for  
10 the operations of the executive branch of the National  
11 Government of the Federated States of Micronesia during  
12 fiscal year 1984. The sum appropriated by this section  
13 shall be apportioned as follows:


