

AN ACT

To appropriate the sum of \$720,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1985, for the purpose of funding public projects in the State of Ponape, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Appropriation. The sum of \$720,000, or so much
2 thereof as may be necessary, is hereby appropriated from the General
3 Fund of the Federated States of Micronesia for the fiscal year ending
4 September 30, 1985, for the purpose of funding public projects in the
5 State of Ponape. The sum appropriated herein shall be apportioned
6 as follows:

7 (1) Uh, Nett, Pingelap, and Mokil public projects. \$134,000

8 (2) Kitti and Madolenihmw public projects

9 (a) Kitti municipal public projects funds shall be
10 apportioned as follows:

11 (i) Rohi and/or Rehntu farm roads. 5,000

12 (ii) Wone water system maintenance. 2,000

13 (iii) Mwakot farm road and/or bridge 5,000

14 (iv) Enipein Powe farm road 2,000

15 (v) Enipein Pah farm road. 2,000

16 (vi) Kipar village road - coral 1,000

17 (vii) Tukunisou road - coral 1,000

9 Section 2. Project execution. All funds appropriated by this
10 act shall be allotted, managed, administered, and accounted for in
11 accordance with applicable law, including, but not limited to, the
12 Financial Management Act of 1979, as amended. The allottee shall be
13 responsible for ensuring that these funds, or so much thereof as may
14 be necessary, are used solely for the purpose specified in this act
15 and that no obligations are incurred in excess of the sum appropriated.
16 The authority of the allottee to obligate funds appropriated by sub-
17 sections (1) and (10) of section 1 of this act shall not commence
18 until January 1, 1985, and this authority for all funds herein
19 appropriated shall lapse as of September 30, 1985.

20 Section 3. Effective date. This act shall become law upon
21 approval by the President of the Federated States of Micronesia or
22 upon its becoming law without such approval.
