AN ACT

To appropriate the sum of \$425,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1989, for the purpose of reimbursing the State governments for a portion of the costs of their law enforcement activities regarding National crimes, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

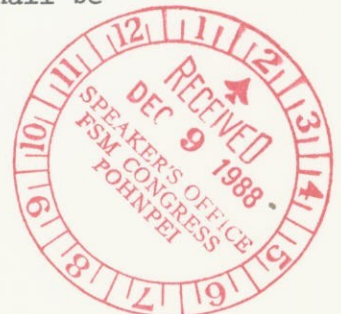
1 Section 1. The sum of \$425,000, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending September
4 30, 1989, for the purpose of reimbursing the State governments for a
5 portion of the costs of their law enforcement activities regarding
6 National crimes.

7 Section 2. The sum appropriated under section 1 of this act
8 shall be apportioned as follows:

- 9 (1) Kosrae State.....\$ 50,000
- 10 (2) Pohnpei State..... 150,000
- 11 (3) Truk State..... 150,000
- 12 (4) Yap State..... 75,000

13 Section 3. Notwithstanding any other provision of this act, no
14 State share apportioned pursuant to section 2 of this act may be
15 allotted unless the President certifies that the State involved has
16 entered into a joint law enforcement agreement for the period of
17 December 1, 1988 to September 30, 1989 with the National Government
18 pursuant to chapter 12 of title 12 of the Code of the Federated
19 States of Micronesia, and that the State involved has waived any claim
20 for reimbursement for costs of law enforcement activities regarding
21 National crimes incurred prior to December 1, 1988.


22 Section 4. All funds appropriated by this act shall be



1 allotted, managed, administered, and accounted for in accordance with
2 applicable law, including, but not limited to, the Financial
3 Management Act of 1979. The allottee shall be responsible for
4 ensuring that these funds, or so much thereof as may be necessary,
5 are used solely for the purpose specified in this act, and that no
6 obligations are incurred in excess of the sum appropriated. The
7 authority of the allottee to obligate funds appropriated by this act
8 shall lapse as of September 30, 1989.

9 Section 5. This act shall become law upon approval by the
10 President of the Federated States of Micronesia or upon its becoming
11 law without such approval.
