

AN ACT

To further amend Public Law No. 5-52, as amended by Public Laws Nos. 5-55, 5-73 and 5-83, by further amending section 12, as amended by Public Law No. 5-73, for the purpose of removing the limitations upon funds appropriated for the Kosrae State Court, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 12 of Public Law No. 5-52, as amended by  
2 Public Law No. 5-73, is hereby further amended to read as follows:

3 "Section 12. Other National Government programs, grants,  
4 subsidies, contributions, and refunds. The sum of  
5 \$1,621,355, or so much thereof as may be necessary, is  
6 hereby appropriated from the General Fund of the Federated  
7 States of Micronesia for the fiscal year ending September  
8 30, 1989, for special programs, grants, subsidies,  
9 contributions, and refunds of the National Government of  
10 the Federated States of Micronesia during fiscal year 1989.  
11 The sum appropriated by this section shall be apportioned  
12 as follows:

- 13 (1) Special programs:
- 14 (a) Congressional election..... \$175,000
- 15 (b) Constitutional convention..... 100,000
- 16 (c) Trade Training and Testing
- 17 Program..... 198,800
- 18 (2) Subsidies and contributions:
- 19 (a) Aid to nonpublic schools for
- 20 secular programs..... 200,000
- 21 (b) Asian Pacific Coconut
- 22 Community..... 4,000


