Public Law No. 6 - 67

AN ACT

To appropriate the sum of \$700,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the purpose of funding Yap State public projects, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$700,000, or so much thereof as may be  
2 necessary, is hereby appropriated from the General Fund of the  
3 Federated States of Micronesia for the fiscal year ending September  
4 30, 1990, for the purpose of funding Yap State public projects.

5 Section 2. The sum appropriated under section 1 of this act  
6 shall be apportioned as follows:

12 Section 3. All funds appropriated by this act shall be allotted,  
13 managed, administered, and accounted for in accordance with applicable  
14 law, including, but not limited to, the Financial Management Act of  
15 1979. The allottee shall have the authority to reprogram up to 15  
16 percent to and from the funds appropriated under each subsection of  
17 section 1 of this act. The allottee shall be the Governor of the  
18 State of Yap, who shall be responsible for ensuring that these  
19 funds, or so much thereof as may be necessary, are used solely for  
20 the purposes specified in this act, and that no obligations are  
21 incurred in excess of the sum appropriated. The authority of the  
22 allottee to obligate funds appropriated by this act shall not lapse  
23 until expended. The funding for any of the projects listed in this  
24 act may be supplemented by other sources of funds. The funding  
25 for the project under subsection (27) of section 2 of this act shall


