

**Public Law No. 8 - 6**

AN ACT

**PRESIDENTIAL COMM. NO. 8-54**  
**FSM CONGRESS**

To further amend Public Law No. 7-78, as amended by Public Laws Nos. 7-80, 7-111, 7-113, 7-127 and 7-129, by further amending section 2, as amended by Public Law No. 7-113, to appropriate the sum of \$204,500 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1993, for the purpose of providing supplemental funding for the operations of the legislative branch, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 7-78, as amended by  
2 Public Law No. 7-113, is hereby further amended to read as follows:

3 "Section 2. Operating expenses of the legislative branch.

4 The sum of \$2,469,625, or so much thereof as may be  
5 necessary, is hereby appropriated from the General Fund of  
6 the Federated States of Micronesia for the fiscal year  
7 ending September 30, 1993, for the operations of the  
8 legislative branch of the National Government of the  
9 Federated States of Micronesia during fiscal year 1993.

10 The sum appropriated by this section shall be apportioned  
11 as follows:



  - 13 (a) Personnel expenses..... \$ 400,100
  - 14 (b) Travel..... 499,500
  - 15 (c) Contractual services, grants,  
16 subsidies, and contributions..... 222,800
  - 17 (d) Others..... 64,000
  - 18 (e) Australian parliamentarians'  
19 visit to the FSM..... 30,000
- 20 (2) Staff Offices
  - 21 (a) Personnel expenses..... 709,375
  - 22 (b) Travel..... 140,000
